All members who plan to help the organization by showing at the qualifying meet come November at Columbus, Ohio, need to coordinate the entries so as to be able to meet the APA and/or ABA admission requirements for new breeds and varieties. Upon the shoulders of Don Cable, our secretary, falls this unenviable and formidable task. So EVERYONE PLEASE let Don know as soon as possible what you can show so that he can advise all of us what to enter in order to avoid duplication of effort in some varieties while perhaps falling just short of the mark in some other varieties.

Only by working together can we achieve the goals we have set for 1983. Through cooperation, hard work, and self-sacrifice we can do it. STAND UP AND BE COUNTED

Those members subscribing to Poultry Press or who are ABA members or both, are now aware of the really serious proposal by Dr. K.G. Keenum, North Carolina Department of Agriculture, regarding the mandatory testing for pullorum and the devastating consequences that the acceptance of this proposal would have on each of us. For those not aware, this proposal, as succinctly outlined by Bill Cawley, of Texas A&M, in the reprint of an editorial sent to all ABA members, would seriously curtail, if not end for all practical purposes, the public exhibition of poultry, especially across state lines. For a copy of the editorial detailing the facts of the matter, contact your secretary.

Whether you exhibit your birds or not, you benefit indirectly from exhibition as it is the chief vehicle for both sustaining interest in the fancy and is the crucible for passing judgment and the free exchange of ideas so necessary for the continued progress of all breeds of poultry. Your chosen avocation is seriously threatened and the exhibition of poultry as we know it, could well come to an end.

This is perhaps the most important message that has been brought to you by way of this bulletin and as your secretary, I must urge you to act upon this vital matter by writing now to:

Be sure to mention that you are opposed to the proposed amendment to Section 145.53 (b) (3) (vii) to NPIP, which was published in the Federal Register, Vol. 48, No. 104/ Friday, May 27, 1983/ Proposed Rules P23829. Please send a copy of your letter to Mr. Gessel to your United States Senators and Congressmen. Even more important, you should send a copy to your state officials- Governor, Commissioner of Agriculture, Legislators, etc. as the increased cost brought about by multiple testing must be born by the state and most State Officials are unaware of the proposed amendment so important to us all.

Remember this is only a proposed amendment, not the law of the land as yet! To prevent this amendment from becoming law, exhibition poultry people must mount one of the largest write-in campaigns in history. Each of us has a stake in this very real threat to our hobby, so let your voice be heard. Mr. Gessel must receive your comments on or before July 26, 1983.
